Privacy Notice Membership Administration

We are concerned about protecting your personal data. With this Data Protection Information, we would like to inform you about the main aspects of data processing in the context of membership administration. For comprehensive information on how ÖGB handles your personal data, see www.oegb.at/datenschutz

ÖGB is the controller for processing your data. We process the data you provided overleaf with utmost confidentiality, only for the purpose of membership administration of the trade union and for as long as you are a member and/or as long as you may still derive rights or claims from your membership. The legal basis of data processing is your membership in ÖGB; to the extent that you have consented to the automatic deduction of your membership dues by your employer, your consent to the processing of the data additionally required for that purpose.

The data are processed either by ÖGB itself or by processors contracted and controlled by ÖGB. The data are not transmitted to third parties in any other way, or only with your explicit consent. The data are exclusively processed within the territory of the EU.

As regards the processing of your personal data, you have a right of access, rectification, erasure as well as a right to restriction of processing. You may at any time lodge a complaint with the Austrian Data Protection Authority (www.dsb.gv.at) as the supervisory authority, if you consider that your personal data have been processed in an unlawful manner.

unemployed persons With unemployed persons who have been employed earlier, the trade union that covered the most recent activity e.g. employees – Union of Salaried Private Sector Employees; construction work – Union of Construction and Woodworkers; work in the field of metal/electric – Union of Production Workers; work in the transport or personal services sector – vida trade union.

Pupils/students That union which matches the desired occupation/profession – e.g. employee – Union of Salaried Private Sector Employees; civil service – Union of Public Services or union (municipal employees); metal work – Union of Production Workers and others; transport or personal services sector – vida.

Freelance and self-employed persons To the extent their activity is comparable to employed persons, Union of Municipal Employees, Art, Media, Sport and Freelance Workers.
